Ascension Trust (Scotland) is a Christian charity which oversees, encourages and enables individual Street Pastor Initiatives in Scotland to operate Street Pastor, Rail Pastor, School Pastor and Response Pastor services throughout Scotland through individual charities at over 20 locations (see www.scotland.ascensiontrust.org.uk/locations) The services also operate elsewhere in the UK and beyond though a separate charity Ascension Trust.

Ascension Trust (Scotland) operates with a volunteer Board of Directors of between 7 and 10 in number who bring differing skills and a real heart of the work of the Street and other Pastors. Street Pastors are trained volunteers who operate in 27 cities and town in Scotland, being out on uniformed patrols most weekends to listen, care and help those out in the late-night restaurants pubs and clubs who might need assistance. The work is a partnership between number of local churches, the police and relevant local authority and is very well received by them as well as those out enjoying themselves during the night. A typical Street Pastor patrol of four trained Pastors operates between 10pm and 4am or even later when needed.

The Board would like to strengthen its range of skills by seeking a new Trustee with a legal background and experience to join the Board for an initial three-year period, which can thereafter be extended if desired by mutual agreement. The Board currently meets virtually by Zoom every two months from 10m to 12noon, usually on Fridays and deliberates of current activities, with a range of short reports provided beforehand. There may be email and telephone communication between Board meetings but these are not numerous or onerous.


