- 4. Who in your workplace do you have serious conversations with? When do these conversations happen? And what are they about?
- 5. Who do you have most to do with in a normal day/week?
- 6. Who is praying for you and your witness at work?
- 7. What's your exact title and what does that mean where you work? What makes for an excellent one of those?
- 8. To whom do you report, and what's (s)he like to work for?
- 9. How are things different at work from a year ago?
- 10. How do you feel on a Monday morning?
- 11. Do many people there know you're a Christian, do you think?
- 12. What's the management's big thing at the moment?
- 13. What do your boss/peers make of you? How would they describe you to me?
- 14. Are there things you've learned at work that you wish we'd put into practise in the church?
- 15. What do you do as soon as you arrive at your workplace? Who's already there? Who talks to whom?
- 16. Does it feel like you're able to connect what you do at work with your love for Christ and desire to serve him?
- 17. Rate yourself as a personal witness at work and discuss.
- 18. How is evangelism in the workplace different from evangelism at home/in friendship groups/the rest of life?
- 19. Identify two ways in which you could be a more consistent and effective Christian in the workplace?
- 20. How many people do you have contact with within a working week? Who are they?
